INFORMATION CLAUSE

CONCERNING THE PROCESSING OF PERSONAL DATA REGISTERED BY VIDEO MONITORING PROVIDED BY LS AIRPORT SERVICES S.A.

In accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons in regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC (Official Journal of the European Union L. 2016.119.1), General Data Protection Regulation, hereinafter referred to as "GDPR", we inform that:

1. Administrator of personal data

The controller of your personal data is LS Airport Services S.A. with headquarters in Warsaw (02-159), at 2b J. Gordon Bennett Street, entered in the register of entrepreneurs kept by the District Court for the Capital City of Warsaw in Warsaw, XIVth Commercial Division of the National Court Register under number 0000355602, share capital in the amount of: PLN 40,440,020.00 (paid in full), NIP: 5222949523 (hereinafter: the **"Company"**).

3. Purposes and lawful basis for processing

The company will process your data for the purpose increasing the safety of the occupants on the premises of the facility, property protection and protection of information the disclosure of which could harm the Company. The above goals will be implemented pursuant to Art. 6 sec. 1 lit. f GDPR, i.e. the legitimate interest of the Company. Monitoring covers the external parts of the Company's infrastructure, as well as hangars, warehouses and corridors in office buildings.

4. Retention periods

Your personal data will be stored for a period of 3 months from the date of recording. In the event that the image recordings constitute evidence in legal proceedings or the Company learns that they may constitute evidence in the proceedings, the data processing period will be extended until the final conclusion of the proceedings.

5. Recipients of personal data

Your personal data may be disclosed to entities authorized under applicable law, authorized employees / associates of the Company and contractors/ subcontractors of the Company, i.e. entities: legal, IT, providing maintenance and administration services for the video monitoring system

6. Rights of data subjects

You have the right to inspect your data, delete it, and the right to limit processing. Your right of access may be limited in justified cases, such as the protection of personal data of other persons covered by the monitoring area or pursuing claims and conducting proceedings by bodies authorized by law.

You have the right to object for reasons related to your particular situation to the processing of your data for the purposes of the legitimate interests of the Company. You have the right to lodge a complaint with the President of the Office for Personal Data Protection (Stawki 2 Street, 00-193 Warsaw).

7. Provision of personal data

The provision of data is voluntary, however, it is an entry requirement to the area of the Company.
